Do Nothing. If you do nothing, you remain in the Settlement. You give up your rights to sue, and you will not receive any monetary Settlement Benefits.

Attend the Final Approval Hearing. The Court will hold a Final Approval Hearing at February 12, 2026, at 1:00 pm via ZOOM. To determine if the Settlement is fair, reasonable, and adequate, to consider an award of combined attorneys' fees, costs and expenses up to \$130,000, and a Class Representative service award of up to \$2,500, and to consider whether and if the Settlement should be finally approved. You may attend the hearing, but you don't have to.

WHAT ARE THE SETTLEMENT BENEFITS AND TERMS?

In the lawsuit *Restek v Restek Corporation*, No. 24-01-01444 (Court of Common Pleas of Philadelphia County, PA), you are a class member compromised in the data security incident that Restek Corporation ("Restek") experienced beginning on or about June 2, 2023.

WHAT ARE YOUR RIGHTS AND OPTIONS?

The Settlement provides the following benefits, subject to a maximum aggregate cap of \$210,000, which will be distributed to Settlement Class Members who submit Valid Claims. Settlement benefits include (1) compensation for Ordinary Out-of-Pocket Losses, up to a total of \$425 per Class Member; (2) compensation for up to four (4) hours of Lost Time, at \$20.00/hour, to be applied toward the \$425 cap for ordinary loss expense reimbursement; (3) reimbursement for Extraordinary Out-of-Pocket Losses, not to exceed \$3,500 per Class Member. In lieu of the above listed Settlement benefits, Class Members may claim an alternative cash payment of \$50.00. Class Members may also claim the non-monetary benefit of two (2) years of single-bureau Identity Theft Protection. Submit a Claim Form.

To qualify for a cash payment, you must timely submit a Claim Form either by mail or online at www.RestekDataSettlement.com. Your Claim Form must be postmarked or submitted online no later than January 9, 2026.

Opt Out. You can opt out of the Settlement and keep your right to sue about the claims in this Lawsuit, but you will not get any money or credit monitoring from the Settlement. You must opt-out by December 9, 2025.

Object. You can stay in the Settlement but tell the Court why you think the Settlement should not be approved. Objections must be submitted by December 9, 2025.

CREDIT MONITORING REQUEST FORM

IDX Identity Protection Services provides single-bureau credit monitoring, dark web monitoring, \$1,000,000 in reimbursement insurance, and fully managed identity recovery and lost wallet assistance.
